## CALL TO ORDER

Supervisor Lemcke called the meeting to order at 6:25 p.m. Supervisor Lemcke recognized former Town Supervisor Jack Jennejahn as being in attendance. Those present participated in the Pledge of Allegiance to the Flag, followed by a moment of silence.

# <u>COMMEMORATION OF THE FIRST MEETING OF THE</u> <u>TOWN OF PARMA</u>

The Parma Town Board commemorated the 200<sup>th</sup> anniversary of the first Town Board meeting for the Town of Parma with a reading of a proclamation by resident Homer Marple. Also on hand were Carolyn Hurlbutt and Nancy Getbehead dressed in period clothing. Copies of the minutes from the first meeting were available to all who attended the meeting.

Supervisor Lemcke noted emergency exit procedures. It was noted that the meeting is being digitally recorded.

# PUBLIC HEARING TO REZONE NORTHERLY PORTION OF 4618 RIDGE ROAD WEST

Kris Schultz, of Schultz Associates was present to represent K & K Property Ventures. They would like to purchase 4618 Ridge Road West and in doing so would like to know that the entire parcel has uniform zoning. They are requesting that approximately 23 acres of the northerly portion of 4618 Ridge Road West be rezoned from Light Industrial to Highway Commercial. He provided a map of the entire parcel and explained the current frontage on Ridge Road West (first 500 feet back) is already zoned Highway Commercial. It is the intent of the buyer to continue the current recreational use on the property and would like the entire parcel to be in conformance to that use.

There was further discussion. It was noted that the current Highway Commercial zoning goes to where the tee area is currently at the Sports Dome. Supervisor Lemcke explained he would open the public comment portion of the hearing, comments would taken from the Town Board and the public hearing portion of the meeting would be closed. The remaining items to be addressed would continue at the end of the informational items to allow Mr. Schultz to attend another commitment.

Supervisor Lemcke asked for public comment. There was no response. The Town Board had no questions.

# **COURT ADDITION**

Scott Fisk, Pardi Partners Architects, summarized the enclosure of the of the tree alcove area at the front of the Town Hall which will not significantly change the footprint for the building. It was noted that \$30,000 in grant money was received to expedite the project. The renovation will be ADA accessible and there will be a walkup window for security. The project will be put out for bid within the next 2 to 2 ½ weeks. The project is expected to start in May and is expected to take a month to complete. The asbestos abatement will be coordinated with the construction.

# <u>CONTINUATION OF PUBLIC HEARING – AGRICULTURAL AND</u> <u>FARMLAND PROTECTION PLAN</u>

Supervisor Lemcke reopened the public hearing and acknowledged Scott Copey. Mr. Copey summarized where the plan was to date. He noted that minor housekeeping corrections had been made to the plan. If approved by the Town Board tonight, the plan will be sent to the NYS Department of Agriculture and Markets for approval. He does not expect any changes from the State's review as they have already seen the drafts and have been supportive of the plan so far. In addition, Mr. Copey asked the Town Board to implement the Plan's recommendation to continue the Farmland and Open Space Committee and requested that consideration be given to having additional representatives from the farming community. Both of these items were recommended by the State for the implementation phase of the Plan. Councilman Smith questioned whether changes might still come from the State. Mr. Copey reiterated the State had been in tune with the entire process and were expecting the Town Board's approval. Councilman Carmestro inquired how many additional members might be included. Mr. Copey explained the current attendance and felt that one or two more would be appropriate.

# **TOWN CLERK REPORT**

The Town Clerk Report and the VFW Summary for March have been submitted. The Clerk noted a representative from the Comptrollers Office was the speaker at a recent Town Clerk Association meeting. They are winding down from their focus on school district audits and will be reestablishing relationships with towns including audits to start in the near future.

Several notifications were received and noted as follows:

A representative from Congressman Lee's office will be at the Parma Town Hall on Wednesday April 22, 2009 from 10:00 to 11:30 a.m. for a satellite visit. Anyone who would like to talk to the representative is encouraged to come.

The Monroe County Soil and Water Conservation will hold an informational regarding the Agricultural Environmental Management (AEM) on April 29<sup>th</sup> from 6:00 to 7:00 p.m.

The 9<sup>th</sup> Annual Ride for Missing Children will take place Friday May 15, 2009. The route in Parma will include drive bys at local schools with a stop at the Quest Elementary School.

The Town of Greece is holding a public hearing on April 21, 2009 regarding proposed zoning changes to the zoning code regarding massage and massage parlors.

The NYS Department of Environmental Conservation is preparing to issue an Individual Water Quality Certification for the proposed realignment of the flow of a tributary of Salmon Creek under Clarkson Parma TL Road 800 feet north of Route 104.

Hilton Rotary has requested use of a room or access to electricity for use during their Easter Egg Hunt. There was no objection.

A pavilion rental was scheduled for a 50<sup>th</sup> Hilton class reunion and had to be cancelled. A refund for the full rental fee has been requested. The Town Board was in agreement to refund the full amount.

## HIGHWAY DEPARTMENT REPORT

Supt. Speer reported the CHIPS state aid has been reinstated into the budget at the same level as last year. He also reported that he is \$37,870 over budget for salt but expects this to be offset by an increase in the J miles the Town will be reimbursed for by the State leaving \$50,000 to the good.

Supt. Speer also reported crews have started chipping brush, have swept the subdivisions, worked on ditches and a culvert pipe on North Avenue and the ditch along Wilder Road. It was noted that a section will have to be piped as a bypass by Marjorie Lane. The Bicentennial signs have been placed where there are existing entry signs to the Town.

Upcoming work will include Spencer Road, Summertime Trail, Highpoint Drive, Rockridge Circle and Alder Beach Road. Supt. Speer has been informed that work on North Avenue will not take place until next year. Work will be done by Monroe County on Curtis Road to the Town Line Road, the west end of Huffer Road, the north end of Bennett Road and the east end of Burritt Road. Hamlin Parma Town Line Road will not be done as previously expected.

#### BIDS FOR 2009 CAB, MUNI-BOX, PLOW AND WING

Supt. Speer reported 1 bid was received from Conway GMC for a 2010 GMC 5500. There was discussion on whether to accept. It was the consensus that the Town Board would like more than 1 bid. It was suggested that the specs be split into 2 separate bids; one for the cab and a second for the box, plow and wing. It was also requested that the legal notice be placed in the *Democrat & Chronicle* as well as the *Suburban News* and that bid packets be mailed to vendors. The bid opening will be the first of May.

**<u>RESOLUTION NO. 101-2009</u>** Motion by Councilman Smith, seconded by Councilman Carmestro, to reject the bid received and re-advertise the truck as 2 separate bids with the same specifications; one for the cab and the second as the Muni-box, wing and plow. A minimum of 3 bid packets will be sent to the appropriate local dealers.

# **RECREATION DEPARTMENT REPORT**

Mr. Fowler presented a proposal for the reallocation of funds proposal for the renting of space in the Village Community Center. A letter had been sent to the Village Board and Mr. Fowler wished to explain the proposal to the Town Board.

The proposal consists of a 10% reduction in the rent payment for the next 5 years and then keeping the lease the same for an additional 5 years through 2019. During this time span, all monies accumulated as a result of this reallocation would be refocused by Hilton-Parma Recreation into the Senior Nutrition Center and senior programming. Mr. Fowler expects a \$1,377.30 overall savings for next year and \$5,640 annually from 2014throught 2018 to senior recreational venues. Mr. Fowler presented statistics for senior program usage and to demonstrate why he has made this proposal. Senior transport costs make up a significant portion of the senior budget with the majority of users being Village residents. It was also noted those who use the service have very limited alternatives for transport. Councilman Blackburn asked if participation has remained the same. Mr. Fowler noted numbers have been steady but made up of different people. Mr. Fowler indicated the department would like to direct additional focus on increasing active senior programs.

Mr. Fowler sought input on how the Town Board would like to proceed. After some discussion, he was asked to provide the proposal in a packet for the joint meeting with the Village next Tuesday, where it would be reviewed.

# PARKS DEPARTMENT

Mr. Petricone reported he had been contacted by the Town of Richmond regarding the surplus skate ramps they wish to sell. He had the opportunity to review them briefly since the last meeting. He would like guidance on what should be paid for the ramps.

#### **CEMETERY MOWING**

Two quotes were provided for maintenance of six (6) cemetery parcels for the Town of Parma as specified in the Parks Department request for quotes. They were:

Mr. Petricone provided information on roof quotes for the VFW and the Historical Building/Museum. It was determined the Town Board would review the information and address at the next Town Board meeting. Mr. Petricone also indicated he expected to have information on resurfacing of courts in the park.

He also reported paperwork to obtain the cost to have gas at the VFW was returned to RG&E. Fence rails were replaced at the cemetery on Dunbar Road. It was noted that a neighbor to the cemetery was willing to do repairs if the materials were supplied. Mr. Cosgrove noted that it was Jim Cobb who has been tending to the cemetery. He also noted the sign has been replaced for the entrance off Parma Center Road.

Mr. Petricone attended the Braddock Bay Wildlife Management Area Committee meeting pertaining to the Bennett Road property. He hopes that a representative from the DEC will come to the next Town Board meeting to explain involvement opportunities for

the Town. The committee is looking into having the property surveyed on both sides so all are aware of the boundary corners.

Neighbors across the road from the Park have reported suspicious activity in the Park on weekends and late at night; often in the skate park. They have called 911 but it is generally over an hour before anyone responds. Supervisor Lemcke will contact the Sheriffs as well.

Discussion returned to the skate park ramps. It was noted the one metal ramp already in the park was \$4,000 and Mr. Petricone would like someone from the Town to see the ramps before a decision is made. It was felt that Councilman Carmestro, Mr. Fowler and Mr. Petricone would set up a time to view the ramps.

# **BUILDING DEPARTMENT REPORT**

Mr. Barton reported the monthly Building Department report has been submitted. Supt. Speer and Mr. Barton have met and are working on the Annual Stormwater Report. The Town of Parma in conjunction with Cornell Cooperative Extension will be offering a seminar titled Great Lakes – Great Lawns to educate homeowners on chemical free ways to maintain their lawns.

## **COURT ADDITION – ASBESTOS ABATEMENT**

Mr. Barton explained the area where the abatement would take place and has received 3 quotes. Each company completed a survey of the site and submitted the following estimates:

Supervisor Lemcke noted that he will be meeting with Don Stilson tomorrow to do before and after pictures of buildings in the Town. The pictures could be displayed by local businesses and they will be researching cost sharing and ways to accomplish this.

# **BUSINESS ITEMS**

#### SOCCER CAMP

Councilman Carmestro has spoken with Doug Miller Soccer. The camp would like the use of the multipurpose field and possibly one other field. The tentative date would be the last week in July. The pavilions should be ample space for inclement weather or extreme heat and they are willing to pay \$15 per participant to cover expenses the Town would incur. An estimate of 100 to 200 participants is expected.

#### **MISCELLANEOUS**

#### SOIL TESTING RESULTS

Supervisor Lemcke provided a chart from the NYS Department of Environmental Conservations for recommended soil cleanup objectives. He reported Paradigm Environmental Services has provided the results for of tests for arsenic in stockpiled soil at Town Hall Park. Chatfield Engineers obtained samples on March 17, 2009. The results were labeled Parma Center Top and Parma Center Bottom. The result for the Parma Center Top sample which is soil from the fire department was 5.11. The result for the Parma Center Bottom sample which was from the Town Park was 4.80. When compared to the DEC chart (7.5 of higher) these amounts are below the threshold of when it is a problem. Supervisor Lemcke will make a copy available for Mr. Chart and the Parks Department. The soil can be used because it falls below the 7.5 threshold and no remediation is required.

#### **EMPLOYEE LAWSUIT**

Genesee Transportation Council – A trail system is proposed from Rt. 390 to the Village of Hilton along the Hojack line. Long term plans include extending the trail system all the way to the Monroe Orleans County line.

Joint Meeting with Village of Hilton – The joint meeting with the Village of Hilton will be held on April 14, 2009 at 6:00 p.m. at the Town Hall.

#### **LIAISON REPORTS**

\*\*Councilman Smith reported Mr. Fritz continues to update code violations since the first of the year. Since the first of the year he has issued 34 complaints, 9 have been resolved and 25 are ongoing.

\*\*Councilman Comardo reported he attended the Recreation and Park Commission meeting. Members complimented the Park Department conveyed their appreciation for the state of the park. State funds for the lighting project are still frozen and there was discussion on other possible sources should this not come through. The rent proposal was reviewed. There is continued interest for an ice skating venue somewhere in the Town. The Village Board requested that they participate in reviewing the Village Park Land Use Design Plan.

The Special Police have participated in training opportunities provided through various police agency. Bike patrols will commence shortly and they have provided assistance with the Village vandalism problem. They will provide a detail for the fire house opening ceremony. They have been asked to participate in ride alongs with the Sheriffs Department.

\*\*Councilman Blackburn did not have a report.

\*\*Councilman Carmestro reported the Fire Department completed their move on Saturday. The dedication will be May 16<sup>th</sup> and the general public is invited.

He had an initial meeting with the VFW Board of Directors to discuss assistance with the roof. Their position is that the building was given to the Town and they will not assist. Councilman has been reviewing rental data and suggested that we review the number of waived fee rentals and at least consider a cleaning fee.

\*\*Supervisor Lemcke reported since there is not going to be a new Library, the Library Board has decided to spend \$60,000 to replace the carpeting, paint and purchase furniture. They complimented Mr. Petricone on completing work to address the Fire Marshall's issues. They are looking at a different company for replacement of the front doors.




