CALL TO ORDER

Supervisor McCann called the meeting to order at 6:30 p.m. and lead those present in the Pledge of Allegiance to the Flag, followed by a moment of silence. Supervisor McCann noted emergency exit procedures.

TOWN CODE CHANGES

PUBLIC HEARING PROPOSED CHANGE TO SECTION 165-82 AA (2) OF THE PARMA TOWN CODE

Supervisor McCann read the following legal notice that was published in the Suburban Newspaper on August 7, 2011 and posted as required.

LEGAL NOTICE TOWN OF PARMA AMENDING THE PARMA TOWN CODE CHAPTER 165 ZONING §165-82 AA (2)

The Parma Town Board has scheduled a public hearing to be held at the Parma Town Hall, 1300 Hilton-Parma Road, Hilton, New York on Tuesday, August 16, 2011 at 6:30 p.m. for the sole purpose to gather public input on the establishment of an effective date regarding Chapter 165 Zoning §165-82 AA (2):

Any individual possessing a purebred license under former Agriculture and Markets Law §109 subdivision 2 shall be required to come into compliance with subdivision (1) of this section on or before <u>date to be determined</u>.

A copy is available by contacting the Parma Town Clerk's Office.

Supervisor McCann opened the public hearing at 6:35 pm and asked if there was anyone who would like to speak.

Tina Blodgett summarized a letter she had sent to the Town Board. She explained that she raises champion American Cocker Spaniels which are like family to her and have placed as high as 13th in the country. She used to breed but no longer does. She indicated that she has had no complaints about the dogs. She would like the Board to take into consideration that the dogs are part of her family and having to give up her dogs because the law has changed is unfair. New owners/breeders would know the rules from the start and would not have to consider breaking up part of their family. Ms. Blodgett felt that all existing breeders should be allowed to care for their dogs until they are no longer with us.

Laurie Harris stated she agreed with the comments of the last speaker. She was a breeder; currently she has six dogs and does not feel she should have to get rid of her dogs. She takes good care of her dogs, there have been no recent complaints about her dogs and they do not cause problems. She did not attend the last meeting because she was not aware of it. She understands that there will be a certain type of variance to apply for to keep her dogs.

Tim Jennings stated that he understands the breeders concerns and it is his interpretation that the law restricts the number of dogs to three. In his opinion this has not been enforced. He wanted those in attendance to realize that there are nine purebred licenses issued in the Town and that only five have more that three dogs. His concern is not about the dogs whose owners are in compliance. He felt that these changes are supposed to deal with those owners that are causing problems. He would like to see the new law be effective immediately. He did not feel that it should be stretched out longer for compliance. Those that do not meet the requirements of the new provisions would have to apply for the special use permit and would be issued a permit if there have been no problems. He felt it would save time, money and personnel if dragged out for several years. He also felt the whole process could be resolved in a couple of months.

Susan Jennings stated that she is not opposed to dog kennels and that if you do not have any complaints you could get a special permit easily without a problem or you could be grandfathered if there are no complaints on record. She felt that for kennels where there are complaints, they should be looked at more carefully and go before the Zoning Board of Appeals immediately rather than waiting eighteen months. She does not see the basis for giving them any more time.

Supervisor McCann asked if there was anyone else who wished to speak. There was no response. The public hearing was closed at 6:40 pm.

Supervisor McCann explained that the Town Board will need to discuss the "grandfather" date timing; make the SEQR determination and pass resolutions for the Code changes. The Board moved forward with making the SEQR declaration. Supervisor McCann read the proposed resolution. (See Resolution No. 134-2011for SEQR Type Declaration)

LOCAL LAW NO. 2-2011 - TOWN BOARD RESOLUTION TO ADOPT AMENDMENTS TO THE PARMA TOWN CODE CHAPTER 165-ZONING

The Supervisor reviewed the proposed local law and noted that the Town Board should discuss the "grandfathering" time period. Councilman Comardo suggested a rather lengthy period of time to the involved dog owners time to ratchet their operations down to come into compliance if they intend to get out of the business, sell the dog or let dogs pass on naturally. He suggest December 31, 2014 as start for discussion.

Supervisor McCann indicated that this will not only affect the purebred license holders but also owners There is no guarantee when applying for a special use permit that it would be received. However if you have no complaints or complications it would seem reasonable that they would be looked upon favorably.

Councilman Carmestro was in agreement with the December 31, 2014 date and felt that this would give these dog owners time to get everything they would need tied up. Councilman Smith indicated that he was going to suggest December of 2013. Councilman Roose was also in agreement with the December 31, 2014 date. The Board was in agreement to have Chapter 165-82 AA (2) read

Any individual possessing a purebred license under former Agriculture and Markets Law §109 subdivision 2 shall be required to come into compliance with subdivision (1) of this section on or before December 31, 2014.

PUBLIC FORUM

Supervisor McCann asked if there was anyone who wished to address the Town Board. He asked Mr. Basso if he wished to speak now rather than wait until the Informational Items of the agenda.

Laurie Harris asked what the charge was to get a special use permit. She was informed that the original application is currently \$150 and typically permits are issued for a period of one to five years and the applicant would come back to the Zoning Board of Appeals for a renewal. The renewal application fee is currently \$30.

Tim Jennings noted that although he appreciates the concern shown for the kennel operators he was severely disappointed with the Board's decision.

<u>MINUTES – JULY 19, 2011</u>

RESOLUTION NO. 146-2011 Motion by Councilman Smith, seconded by Councilman Roose, to accept the minutes of July 19, 2011 as submitted.

INFORMATIONAL ITEM/PUBLIC FORUM CONTINUED

Noise Ordinance Complaint - Lucas Basso reported he has sent a letter to the Town Board regarding a noise concern from a Go-Kart track on Bailey Road. He indicated that he has called the Sheriffs Department but were told they could not address his concern. Mr. Basso thought the Town Board and the Attorney for the Town should look at other ways to address. Councilman Carmestro spoke to the Attorney for the Town and noted that all the decibels were within the legal range. He felt that the Town should not proceed further because there is no violation.

Supervisor McCann indicated he had reviewed the Sheriff's report and the measurements taken were well within the parameters. Supervisor McCann was also not inclined to pursue at this time.

Mr. Basso would like the Town to look into the Doppler Effect created by the noise. He did not feel that any consideration has been given to this. Supervisor McCann suggested that Mr. Basso gather the information and provide it to the judge that originally determined that the racing could continue with decibel restrictions.

Councilman Smith felt that the most the Board could do would be to look into measuring the Doppler Effect and consider incorporating that into our code. He felt there was enough information to consider this.

Supervisor McCann indicated that it was suggested that a survey of other Towns be done for how they address this. Supervisor McCann indicted he would look into but could no commit to a timeframe.

Noise Ordinance for Dogs - Laurie Harris inquired why the Noise Ordinance was not being enforced with the breeder that appears to be the cause of the changes that were just approved. Supervisor McCann noted that they are being addressed through Code Enforcement.

Noise Ordinance Complaint Continued - Scott Nowacki and Kenneth Pettit responded to the complaint made by Mr. Basso. They indicated that they have a very family oriented pastime and that they race for twenty minutes at a time with the Doppler Effect referred to earlier. There is a banked and treed overgrowth area around the track. The carts have mufflers and they water down the track. They race three to four times between in a span of 3:00 to 7:00 or 1:00 and 5:00 and it is always on Saturdays only. They also break for a cookout. They likened the Doppler Effect to that of a fire truck going by. They also noted the distance to Mr. Basso's house is approximately one and a half football fields, is fairly secluded, and not open to public but they invite people and some kids to come.

TOWN CLERK REPORT

The Town Clerk Report and VFW Summary Report for July have been submitted. The Monroe County Health Department, Dr. Heidi Wendel and Dog Control Officer, Art Fritz manned the annual free rabies clinic held on July 17, 2011. There were 86 dogs and 31 cats vaccinated.

A request has been received by a potential homeowners group that would like to use a meeting room at the Town Hall. The exact number of people attending is not known. It was felt that it would be possible only if there was another Town function being held where the building would already be open. The Board was not opposed but does not want to incur expense to have someone here to open and close the building.

HIGHWAY DEPARTMENT REPORT

Supt. Speer reported crews have been doing blacktop and curbing work for the school district and there is one Monroe County job on Hamlin Parma TL Road to complete. They have also addressed a drainage issue in Parma Center and to complete they will be seeking permission from New York State DOT to complete ditch work all the way to Newman Drive on Hilton Parma Corners Road. He also reported that roadwork has begun on the Hill Road Bridge Replacement Project and provided the Town Board with pictures. The job is expected to be completed late October, early November and work is expected to start next May for the second Hill Road bridge and the Collamer Road bridge.

Councilman Carmestro asked if the air-conditioning unit has been installed in the break room yet. Supt. Speer responded that it had not. The unit is at the shop, a hole has to be cut in the cement block wall and then it can be installed. He indicated he would contact the installer tomorrow. Councilman Carmestro asked for clarification on if the Parma

Center Road drainage issues were on Hilton Parma Corners Road or Parma Center Road. Supt. Speer responded that it was on Route 259. Councilman Carmestro noted that he saw the Town's Volvo Drott on private property pulling up chunks of concrete one hundred feet off of Parma Center Road last Friday morning. Supt. Speer stated that some of the concrete had been brought to the side of the road by the owner but there was one piece they could not get out to the road themselves so he said they would get it out.

RECREATION DEPARTMENT REPORT

Mr. Fowler reported the department is in the process of completing the final reimbursement packet for the Town Hall Park Field Lighting Project in the amount of \$26,311.84.

The Fall Brochure is due to the printer on August 22nd and will be distributed to residents by the end of the month.

This year "Make a Difference Day" will take place on Saturday, October 22nd. The town has partnered with Certified Document Destruction and Recycling, Inc. to offer a free community paper shredding opportunity.

The town's summer celebration took place on Saturday, August 6th. An article/thank you has been sent to the Suburban News regarding the event. Estimates from the Parma Special Police, who coordinated the parking, were that the attendance was down from last year's event. Registration from the Annual Camping Jamboree increased from 83 families to 108 families this year. His office received several emails regarding difficulties with camping. Mr. Fowler indicated he witnessed these difficulties and provided the Town Board with correspondence from the Recreation Department to the campers. During the next few weeks, the Camping Jamboree event will be reviewed with recommendations to follow.

Councilman Roose received feedback that the Special Police did an outstanding job with traffic and crowd control. A member of the audience noted that she resides at Parma Corners and the traffic flowed very well.

PARKS DEPARTMENT

Mr. Petricone reported that the Adams Eagle Scout project consisting of blue bird houses in the Town Hall Park and on the State land off Bennett Road to Braddock Bay has been completed. The department's large mower is in the garage for repairs that are estimated to be \$3,000. There was discussion on replacing, other options for mowing and an estimated trade-in of \$11,000.

LIBRARY REPORT

Library Director, Becky Tantillo, provided the Town Board with a Summary of Activities and Statistics for July of 2011. She noted that there were fifteen programs for children with 546 attendees. This is up 200 participants over last year.

HISTORIAN REPORT

Don Stilson informed the Town Board that storm windows over the original stained glass on the west side of the Meetinghouse on Parma Center Road and an 8x8 foot section of roof over the back entrance have to be replaced. There was discussion if there was money available in the current budget. An estimate for both projects is between \$2,300 and \$2,500.

RESOLUTION NO. 147-2011 Motion by Councilman Smith, seconded by Councilman Carmestro, to authorize repairs to windows and the back roof section at the Meetinghouse on Parma Center Road not to exceed \$2,800.

Motion carried: Aye 5 Nay 0

Mr. Stilson estimated that 400 people came through the museum to view the Civil War exhibits and presentations during Parma Fest.

BUSINESS ITEMS

MAKE A DIFFERENCE DAY

BLUE ROCK ENERGY

Information has been received from Blue Rock Energy which will allow the Town to put 50% of our electric usage into a lower fixed rate. This is expected to provide us with a 10-15% price reduction. It was noted that the Finance Director looked at other rates.

Mr. Barton reported that the Building Department Report for July has been submitted and that Websmart Auto has received their Certificate of Occupancy.
