CALL TO ORDER

Supervisor McCann called the meeting to order at 6:30 p.m. and lead those present in the Pledge of Allegiance to the Flag, followed by a moment of silence. Supervisor McCann noted emergency exit procedures.

PUBLIC FORUM

Supervisor McCann asked if there was anyone who wished to address the Town Board.

Tom Ganley informed the Board that he was in the Park this past weekend while the Section V Cross Country meet was being held. He indicated there were 1,000 runners and many people who came to watch. He had the opportunity to speak to several people who attended and shared their comments on how impressed they were with the great park we have. He felt this was a testimony to the work of the Park staff and would like to see the Park advertised more.

TOWN CLERK REPORT

The Town Clerk and VFW Summary reports for October have been submitted. Deer Management Permits for the first come/first serve issuance of permits started today. Collection of school taxes has closed for the Tax Receiver's office. Mail payments will be processed with an October 31st date and the surrender is due next Monday.

HIGHWAY DEPARTMENT REPORT

Supt. Speer reported on the progress of the Hill Road Bridge Replacement Project and is expected to be completed mid November. County projects have been completed. Work on the old bus garage site has also been completed. Crews have been working on the Fall

Brush pickup. A skid steer has been rented to clean out drainage areas where we have drainage easements. Work has also begun to set up equipment for snow plowing.

BUILDING DEPARTMENT REPORT

Mr. Barton reported he has completed the Consolidated Funding Application (CFA) online grant for the installation of a bio-swale behind the sports building parking lot and outlet protection for culvert erosion of the stream bank. The deadline is October 31st.

He will also be modifying the final information for the National Incident Management System (NIMS) report which will be submitted within the next day or two. There was discussion on listing the actual persons or titles of those who will be filling roles. Councilman Smith has completed his certification for Public Information Officer. Tod Edenhofer noted that members of the Special Police are also certified in some of the areas.

RECREATION DEPARTMENT REPORT

Mr. Fowler reported the Recreation Department will be hosting a free Thanksgiving dinner at the Village Community Center. There are seventy people pre-registered and will be sponsored by the Hilton Lions Club. A summary of use for the portable stage and the mobile sign were provided to the Town Board.

MISCELLANEOUS REPORTS

Library Director Becky Tantillo reported the mason is rebuilding the planter at the front of the building and he will be consulted for ideas on ways to remove the graffiti from the building.

BUSINESS ITEMS

APPROVAL OF 2012 PRELIMINARY BUDGET

Supervisor McCann noted that because the Highway Superintendent was unavailable for the last meeting discussion would proceed with the Highway budget. Supt. Speer provided a PowerPoint presentation summarizing the DA and DB budgets for 2012 and changes from last year. He also explained how the Snow and Ice agreements are calculated and noted the minimum we would get is \$471,620. He is projecting 80% for the winter which would be \$507,851. There was discussion on what was budgeted in revenue this year and how much are we actually going to get. He indicated that he is confident that we should get \$188,000 of the \$220,000 budgeted for this year.

There was further discussion on whether other cost savings could be achieved so that the rate would not be increased; consideration of four ten hour days; since there can be no layoffs due to the union contract what about furloughs; the fund balances will not last; increasing the employee portion of the health benefit, the number of employees in the

highway department now versus 1950; the biggest cost to the highway department is employees; additional funding for capital reserves; and reasoning for why the Town pays the Highway Department for services that they provide to the Town.

There was also discussion on the need for two building inspectors, more discussion on health insurance benefits and examples of what is paid in the private sector; and the opinion that the Town has the responsibility to take care of their employees; employees are some of the lowest paid in the county, the number of employees is lower than a lot of municipalities and that this levels the higher health care benefit.

Councilman Smith indicated he would like to see fees raised in the contracts with the sports organizations. Park Revenue would go from a total of \$2750 to \$6,500. This change will be offset to appropriated fund balance in the A Fund. This is a change to what has been proposed in the tentative budget.

MISCELLANEOUS

Street Light - A request for a street light was received by Monroe County to be placed on the curve on Wilder Road between the westerly end of Old Wilder Road and Bennett Road. More information will be gathered on the cost and this will be added to the agenda for the next meeting.

INFORMATIONAL ITEMS

GIS Updates – Jim Zollweg provided the Town Board with examples of how GIS data can be used to gather information and combined. An example given was a map plotting all the houses in Parma and then an overlay was created showing where all the fire hydrants are located in relation to each house. This data could then be used to calculate how many houses are greater than or less than a certain distance from a hydrant. Mr. Zollweg noted two goals he wanted to accomplish which included the establishment of a liaison for GIS and to be more assertive in proposing ideas for procedural changes that

will generate cost savings. Councilman Comardo noted that many private companies use GIS to reduce costs.

LIAISON REPORTS

**Councilman Smith reported he had spoken with the Code Enforcement Officer. There have been 140 citizen complaints year to date and 20 of them are still open. In addition to the remarks already made regarding the cross country meet held at the Park, Councilman Smith noted it was a last minute choice due to weather conditions at the scheduled site. Mr. Fowler did an excellent job coordinating the change and expenses to the Town will be reimbursed.

A significant number of chairs are broken and in need of repair or replacement. They are 5 years old and staff has tried to stay on top of repairs. The Parks Department is proposing the purchase of 25 chairs at about \$16.00 each. It was suggested that they be scotchgarded and that pricing through state contract, Monroe County and Hilton Central School District be looked at.

- **Councilman Comardo reported the Recreation Commission met. Topics included the recent cyclocross event, lower participation in the flu shot clinic, review of the State Consolidating Funding Application and we hope to hear about the vehicle replacement grant in January. It was also noted that there may be public park space at St. Paul's for a soccer field. The Assessor's office has sent out the first round of exemption reminder with a second to follow at the end of the year. There was no Planning Board meeting.
- **Councilman Carmestro reported that the Village is also working on their NIMS assessment. The food shelf lease will be coming up again and it was noted we helped them out last year and that the lease comes up in May. Hilton-Parma and North Greece Fire Districts are finalizing budgets and several candidates have expressed interest in the upcoming elections for North Greece.
- **Councilman Roose reported a request has been received to provide traffic control coverage for the funeral of Vietnam Veteran David Lemcke by the Parma Special Police on November 11th from 2:00 to 8:00 pm. It was decided that a resolution authorizing the Special Police to provide this coverage in the Village was appropriate and that the agreement with the Village would be suspended for the day. The Special Police Chief indicated they are in agreement.

RESOLUTION NO. 203-2011 Motion by Councilman Roose, seconded by Councilman Carmestro, to suspend the agreement with the Village of Hilton made on June 18, 2010 for one day on November 11, 2011 for the purpose of providing traffic control for the funeral of Vietnam Veteran David Lemcke.
